TERMS AND CONDITIONS



ELIGIBILITY

The inventor should have business model based on filed or granted patent in India or elsewhere.

The inventor's firm must be registered in India or elsewhere.

REGISTRATION/NOMINATION

Inventors are required to register and submit their business pitch to IPBazzaar through **Inventor Registration Form** available on IPBazzaar website.

Registration Charge of ₹ 5,000/- is payable to analyze the business pitch as well as provide assistance to inventors for presenting best pitch proposal in front of Jury Panel for final selection

PITCH SELECTION

Based on the selection criteria including the potential of technology, relevance, and probability of investment, the jury will select final entries.

ENTRY CHARGE

Entry charge for inventors in the event (If SHORTLISTED) – $\stackrel{?}{\sim}$ 20,000/- (To be paid before the event)

PRESENTATION AT IP LEAGUE

Finalists will be given 20 minutes each to present their technology and business model before the IP League Panel of investors. Presentation Time 10 minutes and 10 minutes for Investor QnA.

PITCH DECKS

Each inventor is responsible for the information included in his/her pitch deck. It is assumed that you are the sole owner and holder of all rights of use and exploitation.

EVENT

If the inventor is invited to the event, he or she is obliged to pitch or let the IPBazzaar know that they will not attend one week before the event. Due to the exclusivity and logistic of the event, we will charge an entry fee of $\ref{thmatheta}$ 20, 000/- in case you confirm your participation. The invitation to join the event is valid for a maximum of three team members. If the event is cancelled for any reason, the invitations are no longer valid. Within the framework of IPBazzaar, audio, picture and video recordings of the individual participants and the event will be produced free of charge. It is part of the program that the recordings and images/photographs acquired at the event may be used free of charge for press reports, advertising, posters, calendars, magazines, brochures, commercial products and manuals, and on IPBazzaar website and third-party websites (e.g. right of use for YouTube, LinkedIn, Instagram, Facebook, X, etc. acc. to legal requirements) and these rights of use may be given to third parties by IPBazzaar, both free of charge and also in exchange for payment.
